This is the second time that an FDI Annual Congress has taken place in Hong Kong. The first time was in 1995. The world has changed a lot since then. FDI has had to change with it. But let us not look back: what is more important today is the future: where do we want to go, what direction do we want to move in?

I would say that this last year has been a perfect illustration of FDI's power to move forward: after over 100 years working within a specific model oral care that served both the profession and patients well, FDI found itself confronted by a new reality, a watershed moment for our relations with the health authorities, other medical professions and, most of all, the needs and demands for oral health care from peoples around the globe. In short: Oral health as a fundamental human right!

In response, following our meetings in Mexico City, we set up a task force to examine and respond to the opportunities and threats to the profession during the coming years.

The results of these deliberations are laid out in our Vision 2020 document, presented to our members at a special forum yesterday. It is a document to map the future of dental medicine and provide inspiration to the profession and prepare it for the new and exciting partnerships in leading the world to optimal oral health.

Vision 2020 demonstrates FDI's agility and determination to address issues such as the huge disparities in access to oral care between countries and within countries between urban rural areas.

Mr Minister, I am well informed of the steps you have taken and the contribution you have made to furthering the cause of oral health and increasing access in the People's Republic of China. It is a huge challenge. May we congratulate you for taking this initiative.

On the international level, FDI is taking up the same challenge at this landmark Congress under the theme 'Leading the world to a new century of oral health'.

I would like to thank our colleagues at the Hong Kong Dental Association—and in particular my friend Dr Sigmund Leung—for all your efforts in making this event here today possible.

Ladies and gentlemen, this is a very special occasion: today we are celebrating the 100th FDI Annual World Dental Congress. Welcome to Hong Kong, welcome to our 100th congress. Enjoy!
